It is my pleasure to provide this reference letter for Mr. Dimitar Hadzhiyski whom I met in the course of my work, first, as a Liaison Prosecutor between the Republic of Croatia and EUROJUST and later on - after the accession of Croatia to the EU - in my capacity of the first National Member for Croatia at EUROJUST. Since September 2009 I have been actively participating in the work of EUROJUST within the framework of the competences of a Liaison Prosecutors and of a National Member.

I have the pleasure of working closely with Public Prosecutor Dimitar Hadzhiyski, for more than 10 years in a very trustful and effective way.

During the cooperation with other European Union Member States, I have also worked on a case involving the execution of a Mutual Legal Assistance request (Letter Rogatory), sent to the competent judicial authorities of the Republic of Bulgaria, with regards to a complex criminal investigation in the Republic of Croatia.

It is my pleasure to write this letter of recommendation for Mr. Dimitar Hadzhiyski, a public prosecutor in Bulgaria, as well as Assistant to the National Member of Bulgaria for Eurojust, whom I first met in a professional capacity during the international event "Euro South East Conference". This conference gathered all major European experts in fighting euro counterfeiting and took place in Budapest from 21 to 25 October 2012. During this event prosecutor Hadzhiyski delivered a very interesting presentation regarding international legal cooperation, combating serious trans-border crime, the role of Eurojust and the practical application of Joint Investigation Teams (JITs) and we both co-chaired the judicial workshop with the participation of all prosecutors present at the conference.

After the Conference prosecutor Hadzhiyski and I continued our fruitful collaboration in further initiatives. With his legal expertise and professional knowledge in EU criminal justice he has supported many activities of the European Commission in the context of Pericles and Pericles 2020 programme, such as expert missions to Bulgaria (2013 and 2019), Croatia (2014, Mar 2016, Oct 2016, 2018), Montenegro (2014 and 2017), Italy (2016), Romania (2018) and Serbia (2018).

His role was to provide legal expertise, support and training to prosecutors, law enforcement authorities, customs, central banks and other involved stakeholders, as well as EU institutions, such as EUROPOL, European Central Bank, OLAF.

One of the major projects that we jointly worked on was the organisation of the Pericles training "Strengthening the protection of the euro in the Black Sea" that took place in Sofia on 08-10 October 2013. This seminar was jointly organized by OLAF and the Public

Prosecutor's Office of Bulgaria and involved prosecutors, police officers, customs representatives and banking staff from 14 countries in South-East Europe, as well as officials from OLAF, Europol, Eurojust and the European Central Bank. Also in this occasion, I was particularly impressed by the prompt and effective support provided by Mr. Hadzhiyski: his efficient communication skills, excellent organizational and interpersonal qualities strongly contributed to the success of the conference. In addition, he also delivered a presentation on the role of Eurojust and the measures against the euro counterfeiting.

In 2018 prosecutor Hadzhiyski facilitated the contact between the European Commission, Directorate-General for Economic and Financial Affairs and the Bulgarian Prosecutor General's Office that resulted in the notification of the Public Prosecutors' office of Bulgaria in 2019 as a competent national authority regarding Council Regulation (EC) No 1338/2001of 28 June 2001 laying down measures necessary for the protection of the euro against counterfeiting.

As a result, currently the Public Prosecutors' office of Bulgaria organizes with the financial support of the European Commission an international conference on the topic, that is to be held in Sofia in the near future.

On the basis of my direct experience, I am convinced that Mr Hadzhiyski is a very proactive and reliable colleague who approaches his work with great professionalism and interest. He has an in-depth knowledge and experience in the field of mutual legal assistance in criminal matters, as well as he is very much acquainted with the topic of judicial cooperation in euro counterfeiting cases.
